Figure 1 *Front View*

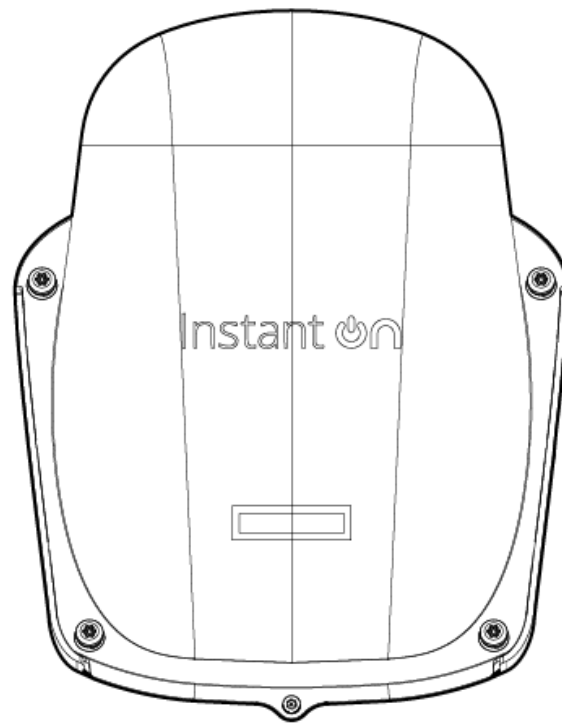
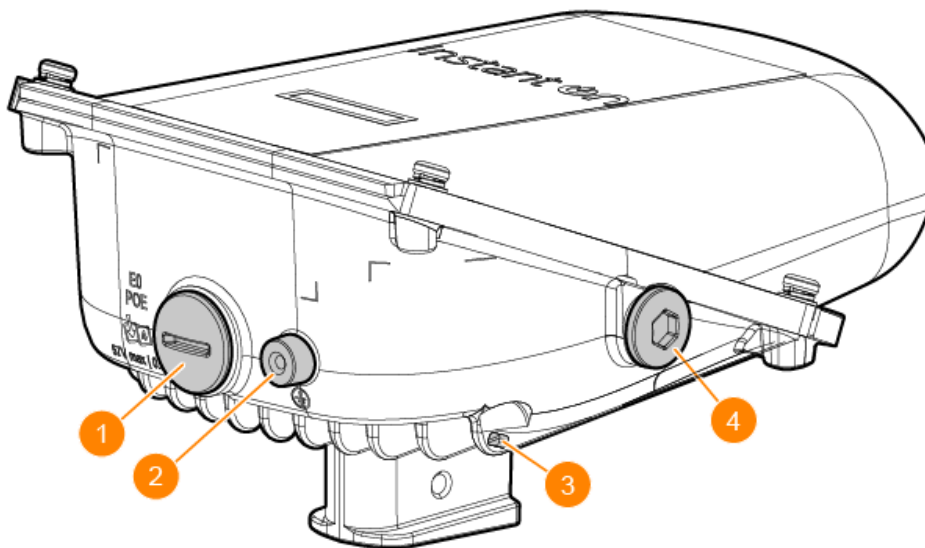


Figure 2 *Ports and LED*

Color/State	Meaning
No lights	The AP has no power.
Green- blinking ¹	The AP is booting, not ready.
Green- solid	The AP is ready, fully functional, no network restrictions.
Green/Amber - alternating ²	The AP is ready for configurations.
Amber- solid	The AP has detected a problem.
Red- solid	The AP has an issue - immediate action required.

1. Blinking: one second on, one second off, 2 seconds cycle.

2. Alternating: one second each color, 2 second cycle.

Reset Button

The reset button can be used to reset the access point to factory default settings.

There are two ways to reset the access point to factory default settings:

- To reset the AP during normal operation, press and hold down the reset button using a small, narrow object such as a paper clip for more than 10 seconds during normal operation.
- To reset the AP while powering up, follow these steps:
 1. Press and hold down the reset button using a small, narrow object such as a paper clip while the access point is not powered on.
 2. Connect the power supply to the access point while the reset button is being held down.
 3. Release the reset button on the access point after 15 seconds.

Ethernet Port

The HPE Networking Instant On Access Point AP27 is equipped with one 100/1000 Base-T, auto-sensing MDI/MDX Ethernet port (E0). The E0 port supports IEEE 802.3at Power over Ethernet (PoE), allowing the AP to draw power from compliant PoE power sources.

Grounding Point

Always remember to protect the access point by installing grounding lines. The ground connection must be complete before connecting power to the access point enclosure.



All Hewlett Packard Enterprise access points should be professionally installed by a professional installer. The installer is responsible for ensuring that grounding is available and meets applicable national and electrical codes. Pre-Installation Checklist

Before installing the access point, be sure that you have the following (not included with the AP):

- One or two Cat5E or better UTP cables with network access

Some optional items:

- A compatible PoE injector with power cord

Refer to the HPE Networking Instant On Access Point AP27 data sheet for compatible items, quantities needed, etc.

Identifying Specific Installation Locations



The HPE Networking Instant On Access Point AP27 is designed in compliance with governmental requirements, so that only authorized network administrators can change configuration settings. For more information about AP configuration, refer to the Instant On User Guide.



Use of this equipment adjacent to or stacked with other equipment should be avoided because it could result in improper operation. If such use is necessary, this equipment and the other equipment should be observed to verify that they are operating normally.

Use the access point placement map generated by Hewlett Packard Enterprise RF Plan software application to determine the proper installation location(s). Each location should be as close as possible to the center of the intended coverage area and should be free from obstructions or obvious sources of interference. These RF absorbers/reflectors/interference sources will impact RF propagation and should be accounted for during the planning phase and adjusted for in RF plan.

Identifying Known RF Absorbers/Reflectors/Interference Sources

Identifying known RF absorbers, reflectors, and interference sources while in the field during the installation phase is critical. Make sure that these sources are taken into consideration when you attach an access point to its fixed location.

RF absorbers include:

- Cement/ concrete—Old concrete has high levels of water dissipation, which dries out the concrete, allowing for potential RF propagation. New concrete has high levels of water concentration in the concrete, blocking RF signals.
- Natural Items—Fish tanks, water fountains, ponds, and trees
- Brick

RF reflectors include:

- Metal Objects—Metal pans between floors, rebar, fire doors, air conditioning/heating ducts, mesh windows, blinds, chain link fences (depending on aperture size), refrigerators, racks, shelves, and filing cabinets.
- Do not place an access point between two air conditioning/heating ducts. Make sure that access points are placed below ducts to avoid RF disturbances.

RF interference sources include:

- Microwave ovens and other 2.4 or 5 GHz objects (such as cordless phones)
- Cordless headset such as those used in call centers or lunch rooms

Access Point Installation

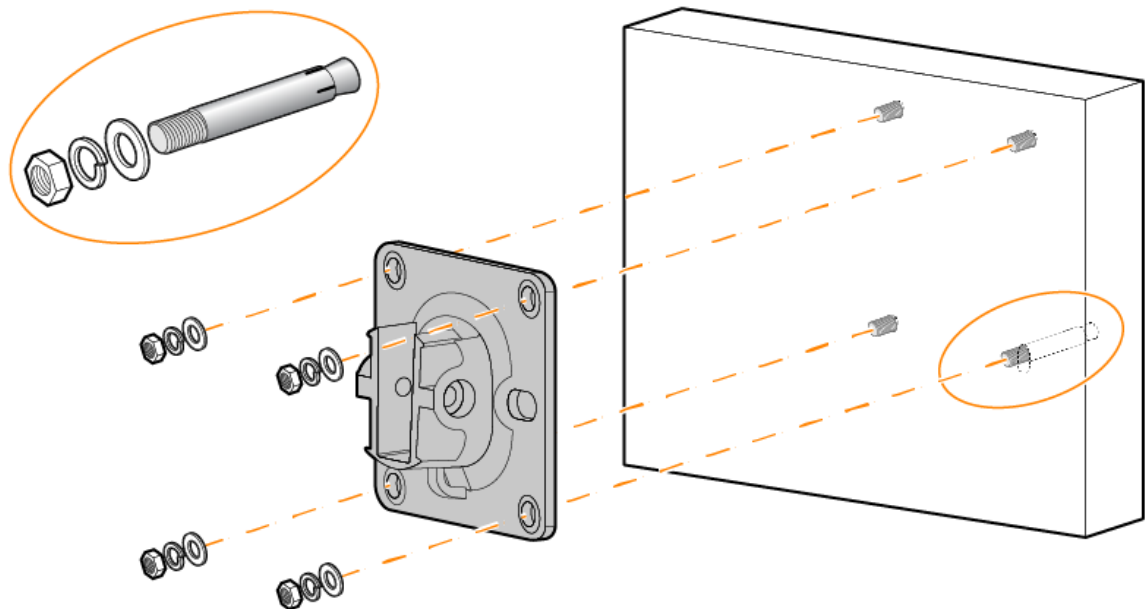
Mounting the AP to a Solid Surface

The HPE Networking Instant On Access Point AP27 ships with a mount bracket to mount the AP to a solid surface, such as a wall.

To install the HPE Networking Instant On Access Point AP27 to a wall, follow these steps:

1. Use the mount bracket as the template to mark the four mounting points on the wall, and use a drill to make four holes on the four markings.
2. Insert an anchor bolt (not included in the package) into each drilled hole, then place the mount bracket over the anchor bolts, and press the mount bracket against the wall.
3. Place the washers and a nut onto each bolt's threaded end, and tighten the nut until the mount bracket is firmly attached to the wall.

4. Slide the holder of the AP into the opening of the mount bracket, and use the two M6 x 20 screws included in the package to secure the AP to the mount bracket.

Figure 4 *Sliding AP to Mount Bracket*

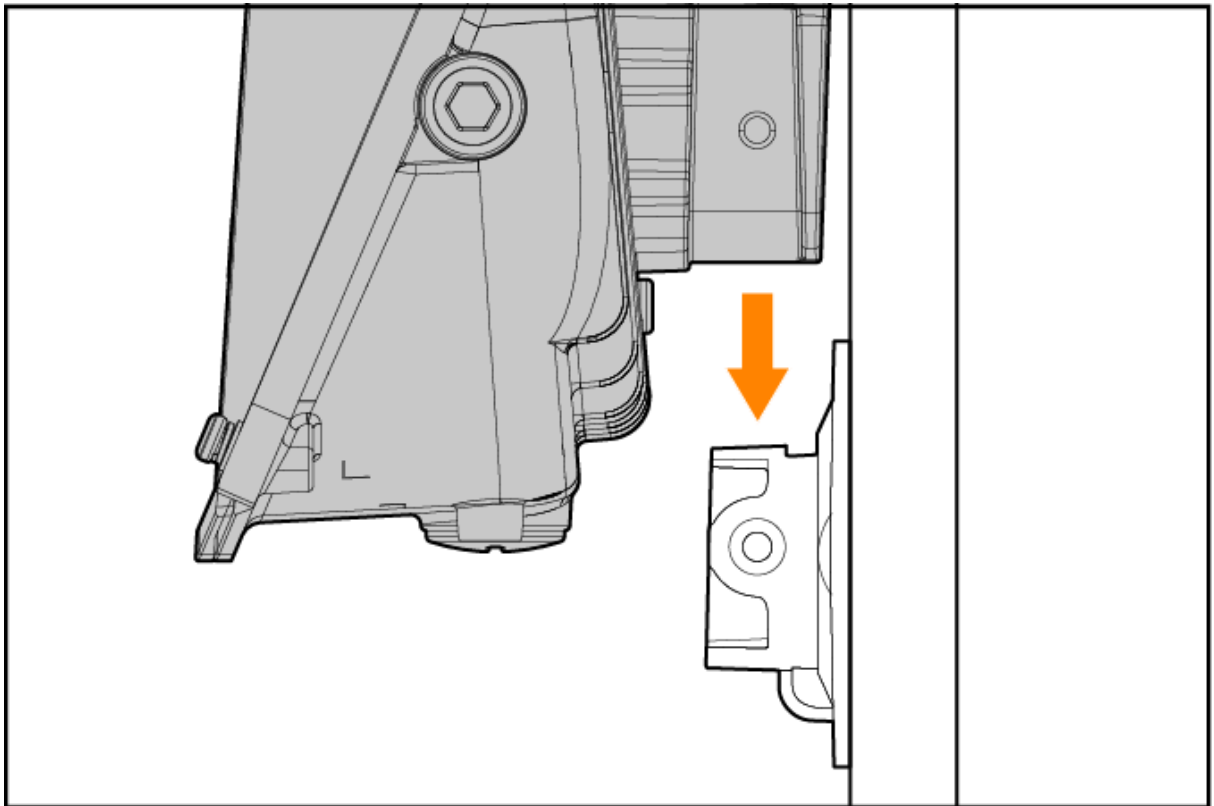


Figure 5 *Securing AP to Mount Bracket*

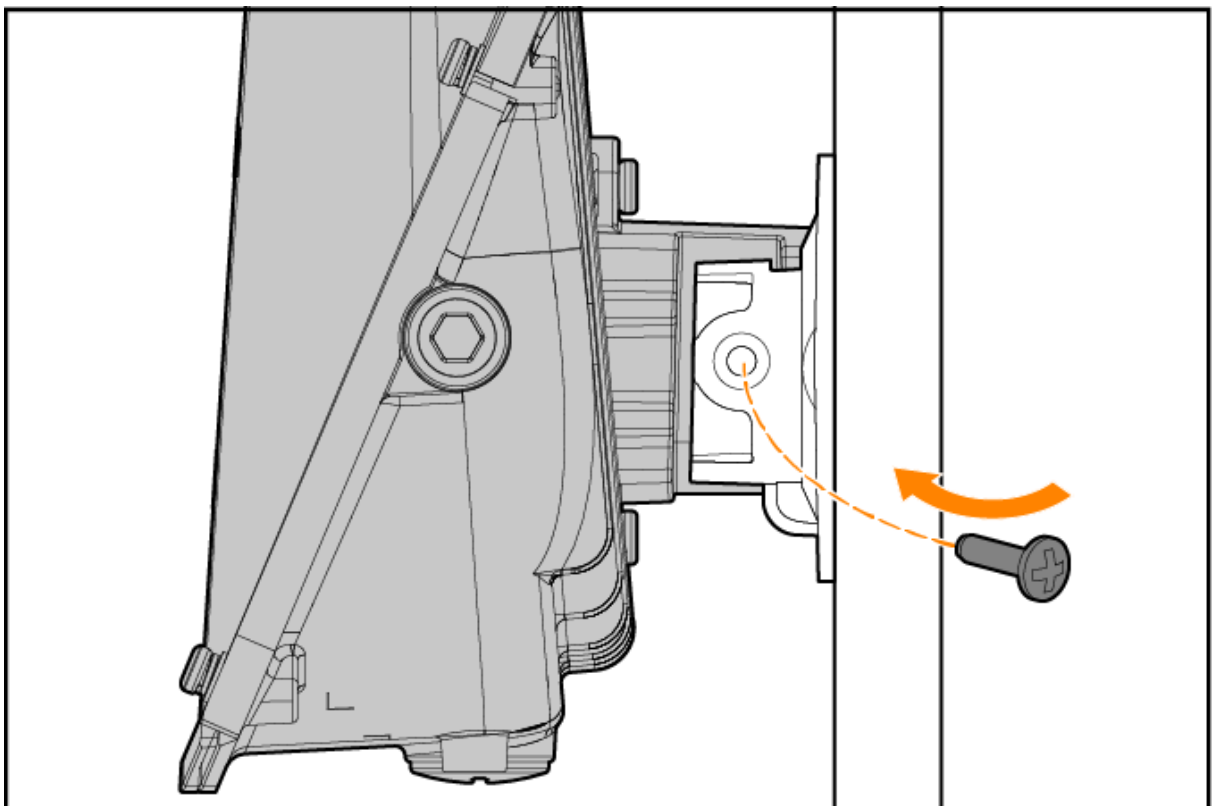
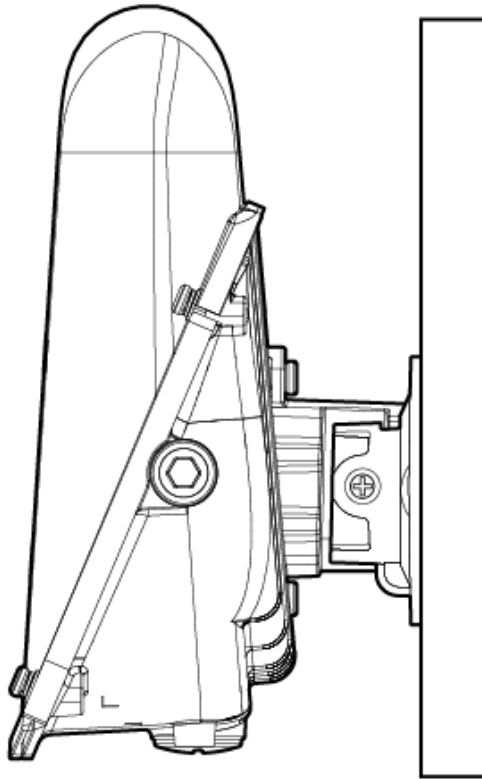


Figure 6 *Securing AP to Mount Bracket (Completed)*



Mounting the AP to a Pole

The HPE Networking Instant On Access Point AP27 can also be mounted to a pole by using the AP-270-MNT-H1 mount kit (Part number: JW054A). The AP-270-MNT-H1 is not included in the package and must be purchased separately. Refer to the [AP-270-MNT-H1 Installation Guide](#) for installation instructions.

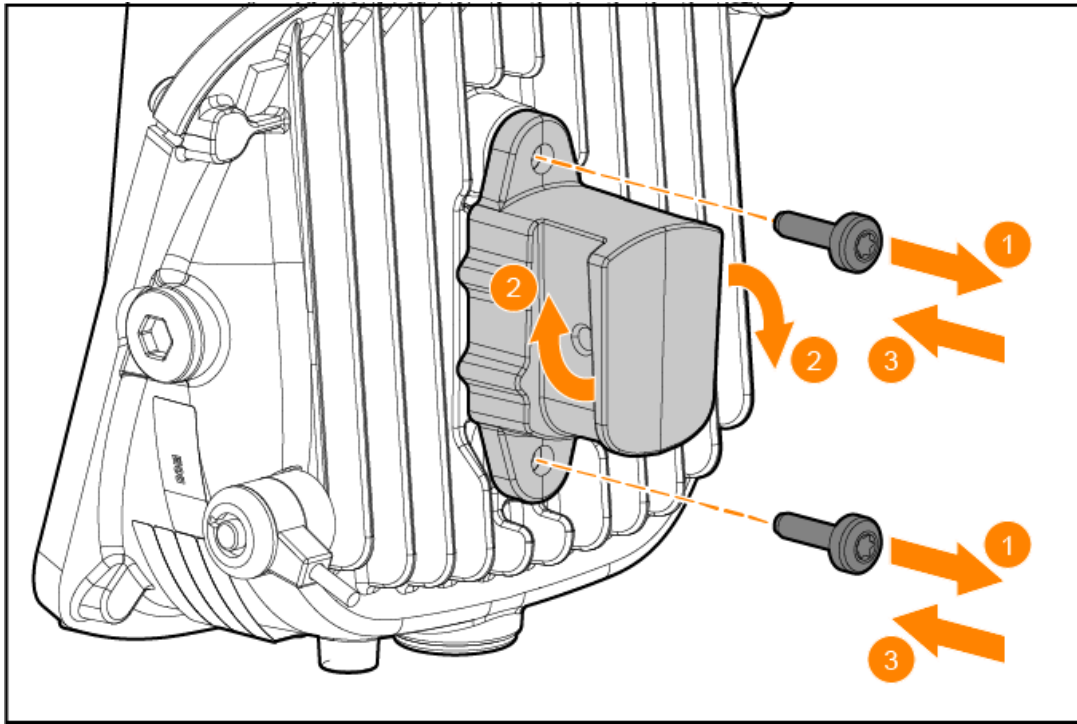


For best Wi-Fi signal coverage, it is recommended that the AP shall be mounted vertically with the antenna cover towards up or down.

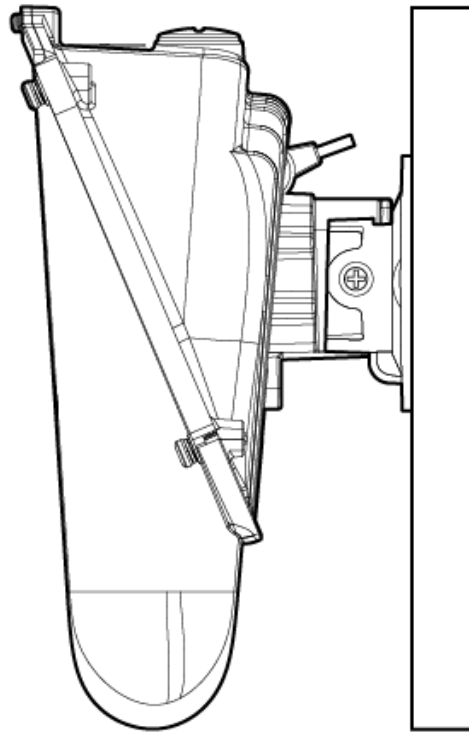
Mounting the AP Upside Down

To mount the AP upside down, follow these steps:

1. Loosen and remove the two screws from the holder to remove the holder from the AP.
2. Turn the holder upside down, and then use the removed two screws to fix the holder to the AP.



3. Slide the holder of the AP into the opening of the mount bracket, and use the two M6 x 20 screws included in the package to secure the AP to the mount bracket.



Grounding the AP

The grounding must be completed before powering up the access point. The grounding wire should be #8 AWG. To ground the AP, follow these steps:

1. Peel the cover of one end of the grounding wire and place the bare grounding wire into the included copper lug, and press firmly with the crimping pliers.
2. Fasten the copper lug to the grounding hole on the AP with the included M4 x 6 screw.

Powering the AP

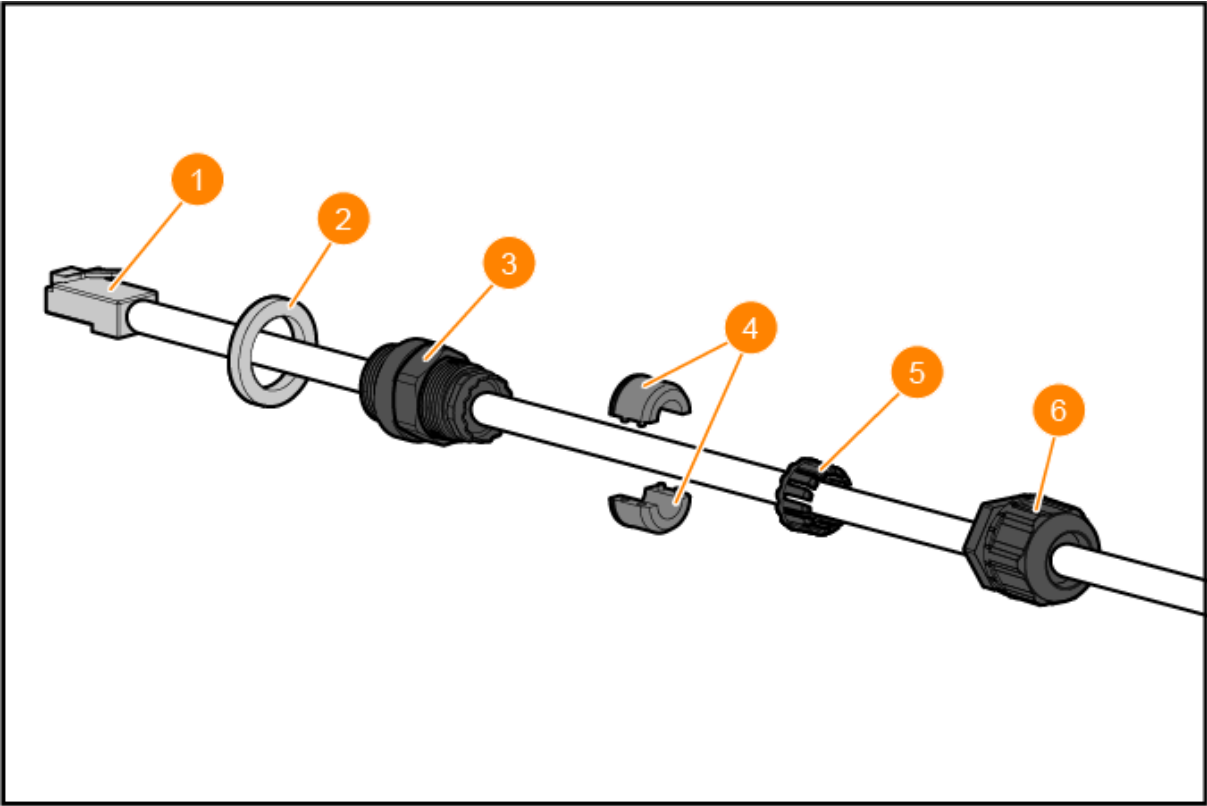
To power the AP, connect an outdoor rated Cat5e or above Ethernet cable from the Ethernet port of the AP to a PoE port of a compliant PoE Injector.

The PoE injector will be installed indoors and then a long cable will have to run from inside to outside where the AP is located. This cable will then be powering the AP. The PoE injector is not meant for outdoor installation as it is not weather tolerant.

To connect the Ethernet cable to the access point, perform the following steps using the M20 cable gland.

1. Remove the dust cap from the Ethernet port.
2. Slide the sealing nut, clip, seals, gland body, and O-ring over the cable.
3. Insert the RJ45 connector to the Ethernet port on the AP.
4. Place the O-ring on the gland body, and ensure it is in place.
5. Thread the gland body into the Ethernet port and tighten to a torque of 8.9 in/lbs (1.0 Nm).
6. Combine the two split seals over the cable, and place them on the gland body.
7. Move the clip towards the gland body, passing over the seals, until the clip properly fits into the gland body.
8. Tighten the sealing nut onto the gland body to a torque of 8.9 in/lbs (1.0 Nm).
9. Connect the other end of the Ethernet cable to a PoE port of a compliant PoE Injector or PoE switch.

Failure to use the included Ethernet cable gland can lead to connectivity and POE issues.



Outdoor rated Cat5e or above cable should be used for all outdoor wired Ethernet connections and should be grounded through the AC ground of the PoE.



Two sets of seals are provided in the package for use with the Ethernet cables. One is applicable for cables with 4-6 mm diameter, and the other is applicable for cables with 6-10 mm diameter.

Verifying Post-Installation Connectivity

The integrated LED on the access point can be used to verify that the access point is receiving power and initializing successfully .
